A number of collections are within this group. The main collection is the Coleman Collection, 1757-1940, regarding various interests of the Colemans. The Coleman family was the most important contribution to industrial life of the Lebanon Valley and it participated in the early growth of the iron industry. The Colemans operated Cornwall Charcoal Furnace; Colebrook Furnace (Mt. Joy Furnace), 1791-1858; Union Forge, 1798-1802; Cornwall Anthracite Furnace, Lebanon Furnaces, Hopewell Forge, Elizabeth Furnace, Mount Hope Furnace.
